I am a settler on turtle island, and I have had the privilege of living on the ancestral lands of the Lekwungen/Songhees peoples of Victoria, BC, and the Wolastoqiyik, Peskotomuhkatiyik and Mi'kmaq peoples of Fredericton and Saint John, NB.

I acknowledge that we are currently on the ancestral lands of the Anishinaabe, Inninew, Anish-Inninew, Dakota and Dene peoples and acknowledge this land as the birthplace and homeland of the Metis Nation. The seven First Nations of this area agreed to share the land we live and work on through Treaty Number One in 1871 and I am grateful for their generosity.

I respect and acknowledge the harms and mistakes, both past and present, and I will continue to collaborate in partnership with First Nation, Metis, and Inuit people in the spirit of reconciliation.
