# Maximum Family Fees

- \$1,104.00 for one K to Grade 5 student and one Grade 6 to 8 student
- \$1,170.00 for two or more Grade 6 to 8 students
- \$1,239.00 for one K to Grade 5 student, and one Grade 9 to 12 student
- \$1,305.00 for one Grade 6 to 8 student and one Grade 9 to 12 student
- \$1,540.00 for two or more Grade 9 to 12 students

NOTE: There is no reduction for high school students

Comment: The Division has tied its transportation fee increase to that of the City of Winnipeg Transit fare increase. For 2023 the City Youth transit fare is \$770.
