Maximum Family Fees:

- \$1,206.00 for two or more Kindergarten to Grade 7
- \$1,438.00 for one K to 6 and one 7 to 12
- \$1,770.00 for two or more Grades 7 to 12

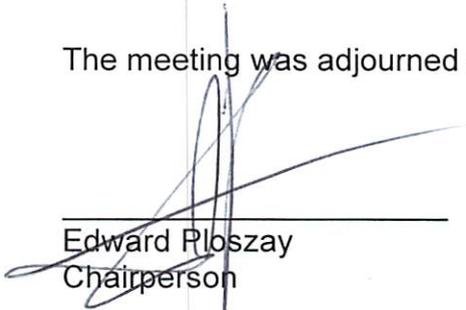

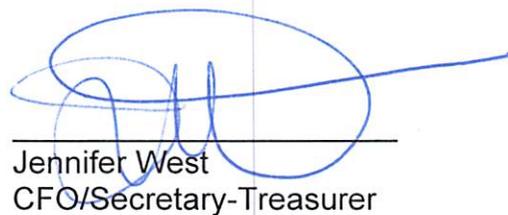
