I am not aware of what motivated my ancestors to move across an ocean, but I am very thankful that I am now able to call this land home. The generosity and continued grace that Indigenous people exemplify is appreciated beyond measure. I acknowledge the Indigenous peoples who were forced from their lands to make way for the new settlers. I recognize the harms and mistakes of the past and as well as the current societal structures and systems that benefit me and continue to oppress others. I am working to uncover and understand the mistakes of the past, and of MY past so that I can authentically commit to working towards truth, justice, and reconciliation."
