#### New Business -

- Presentation by the Lions Club Patricia, Glen, Jay Background:
  - Lion's Club has been in West St. Paul since 2009
  - they are a service organization and made up of all volunteers
  - they do Chase the Ace on Thursdays to raise money
  - they already help the school out each year
    - in the past, this money has been used for e-readers, books, uniforms, milk program, breakfast club, etc.
  - they also help out with sending kid(s) to camp
  - they host a Peace Poster contest; Anna is this year's winner

#### Funding opportunity:

- they here to see what they can help us out with
- there is opportunity to apply for a grant to Lions International dollar for dollar -

- ie. \$15 000 donated here and then Lions International would do \$15 000 (US) but takes 2 years to access that money
- OR we could access a 1 year grant for \$1000 and could that do now (no wait)
- they want to be involved in the school community and help out with some of our events

### **Administrative Report:**

- current enrollment: 602 students
- admin has met with the superintendents' teams to determine staffing for next year
- 2 portables should be here next September; so admin requested for 2 new teachers
- this alleviates some of the pressure in the building
- David asked about the portables today; the division is still negotiating with Hydro; they are now looking at possibility of underground wiring
- the portables will go north of the four that are there now
- the province put out a request for proposals for feasibility studies (consulting) for the daycare; they will then work with the school division to determine next steps
- another 2 portables have been requested by the division
- On Fri, Feb 28th, the school will host the Human Library: there will be lots of visitors reading books to our kids
  - lots of fun activities for I Love to Read Month
- March 11th report cards are available online
- Parent Teacher interviews: Thursday, March 12 (evening) and Friday, March 13 (day)
- The school is working towards having an assembly for Black History Month; they are getting more student voice to help plan
  - possibly just for the middle years grades; speakers include a rapper (former student) and some community leaders
- UNESCO club presented at a teacher PD day; it was well received
- students are doing the Jack Frost Challenge
- lots of indoor recesses the kids want to get out! David or the other principals make the call when they are outside at recess. There is no specific number or policy about "too cold," but is consensus among the adults
